**APPLICATION DIRECTIONS**  
**MICE AND MEADOW VOLES:** Place a single unit at each placement location. Space placements at 8- to 12-ft. intervals. Replace units if contents are consumed or contaminated, or if units are severely damaged. If units are untouched after 3 days, move units to new locations consistent with label text. Maintain an uninterrupted supply of fresh bait for at least 15 days or until there no longer are signs of new feeding by mice or meadow voles.

**FOLLOW-UP:** Replace contaminated or spoiled bait immediately. Using barrier laminate gloves, collect and dispose of all dead, exposed animals and leftover bait properly. To discourage reinfestation, limit sources of rodent food, water, and harborage as much as possible. If reinfestation does occur, repeat treatment.
