For use:

On sheep, goats, beef and dairy cattle, hogs, dogs, horses, and poultry to control flies, gnats, mosquitoes, lice, and mites. For use indoors and outdoors (including poultry houses) to control flies, gnats, mosquitoes, lice, and mites.

On livestock:

To control horn flies, face flies, house flies, mosquitoes, and gnats on cattle, goats, sheep, hogs, and horses: apply a light mist of Prozap Sheep & Goat Spray, sufficient to wet the surface of the hair. For face flies, spray face and head. Do not spray into eyes.

To control stable flies, horse flies, and deer flies: apply Prozap Sheep & Goat Spray at a rate of 2 ounces per adult animal, sufficient to wet hair thoroughly. Repeat treatment daily or at regular intervals.

To control blood-sucking lice: apply Prozap Sheep & Goat Spray to the infested area using a stiff brush to get the spray to the base of the hair. Repeat every 3 weeks if required.

To control poultry lice: spray roosts, walls, and nests or cages thoroughly, followed by spraying over the birds with a fine mist.

To control bed bugs and mites in poultry houses: spray into crevices of roost poles, cracks in walls, and cracks in nests where bed bugs and mites hide.

Purpose:

Prozap Sheep & Goat Spray is an ideal fly, gnat, and mosquito spray for use on sheep, goats, and other listed animals. Contains 0.5% permethrin.
