This product may only be used to control Norway rats, roof rats and house mice *in and within* 100 feet of agricultural buildings and man-made agricultural structures constructed in a manner so as to be vulnerable to commensal rodent invasions and/or harboring or attracting rodent infestations. Fence and perimeter baiting beyond 100 feet from an agricultural structure as defined above is prohibited. This product must not be applied directly to food or feed crops. Do not broadcast bait.

Do not use in homes or other human residences. Do not place near or inside of ventilation duct openings. Do not contaminate water, food, feedstuffs, food- or feed-handling equipment, milk- or meat-handling equipment, or surfaces that come into direct contact with food. **Hazards to Humans and Domestic Animals**

**CAUTION**

**NOTE TO PHYSICIAN:**

If swallowed, this material may reduce the clotting ability of the blood and cause bleeding. If ingested, administer Vitamin K intramuscularly or orally. Vitamin K is antidotal at doses of 10-20 mg (not mg/kg). Repeat as necessary based on monitoring of prothrombin times.

**TREATMENT FOR PET POISONING**

If animal eats bait, call veterinarian or **HOT LINE NUMBER** at once.

**NOTE TO VETERINARIAN**

**Anticoagulant Brodifacoum:** For animals ingesting bait and/or showing poisoning signs (bleeding or elevated prothrombin times), give Vitamin K at doses of 2-5 mg/kg, if needed, check prothrombin times every 3 days until values return to normal (up to 30 days). In severe cases, blood transfusions may be needed.

**APPLICATION DIRECTIONS**

**Norway and Roof Rats:**  
Apply 4-22 (20 g (0.7 oz)) **Havoc-XT Bloks Kills Rats and Mice** (usually at intervals of 15-30 ft) per placement. Maintain an uninterrupted supply of fresh bait for 10 days or until signs of rat activity cease.

**House Mice:**  
Apply 1 bait block per placement. Space placements at intervals of 8-12 ft. Two blocks may be needed at points of very high mouse activity. Maintain an uninterrupted supply of fresh bait for 15 days or until signs of mouse activity cease.

**Follow-Up:**  
Replace contaminated or spoiled bait immediately. Collect and dispose of all dead animals and (when baiting operations are to be ceased) unconsumed bait according to the **Disposal** paragraph. To prevent re-infestation, limit food, water and harborage as much as possible. If re-infestation does occur, repeat treatment. Where a continuous source of infestation is present, establish or maintain bait stations and replenish with census or toxic bait as needed.

**STORAGE AND DISPOSAL**

Do not contaminate water, food or feed by storage or disposal.
