ALFALFA

USE RESTRICTIONS: For control of vole (*Microtus spp*) complex in alfalfa. All applications must occur shortly after a cutting of the hay, and/or prior to the new growth attaining a length of 2 inches. Alfalfa forage from treated areas must not be harvested until it reaches maturity. Do not apply this product to alfalfa within 30 days of harvest.

BROADCAST BAITING: This product may be broadcast by air or ground driven dispensing devices. Apply Prozap® Zinc Phosphide Pellets at a rate of 6 to 10 lbs. (1.2 to 0.2 lb active) per acre. A second application may be made after 10 days. A maximum of 20 lbs. (0.4 lb active) per acre may be applied per year. Do not apply by air when wind velocity exceeds 10 mph. Do not apply in piles or permit piles to be formed by equipment.

TIMOTHY AND TIMOTHY/ALFALFA PRODUCED FOR HAY

USE RESTRICTIONS: For control of vole complex (*Microtus spp*) in timothy and timothy/alfalfa mixtures. Do not apply by air. Do not apply to actively growing timothy or timothy/alfalfa mixtures. Do not apply this product to Timothy and Timothy/Alfalfa mixtures within 60 days of harvest. A minimum of 158 days must pass between an application of Zinc Phosphide Pellets and any livestock foraging activity.

BROADCAST BAITING: This product may be broadcast by hand, cyclone seeder, or ground-driven dispensing devices at a rate of 6 to 10 lbs. (1.2 to 0.2 lb active) per acre during crop dormancy. A maximum of 20 lbs. (0.4 lb active) per acre may be applied per year.

RESTRICTIONS

- Do not apply zinc phosphide within a 100-foot radius of potable wells.
- Do not apply zinc phosphide within 40 feet of any watercourse, which includes ditches, irrigation canals, drainage areas, or other areas where surface water is present.
- Do not inject or introduce Zinc Phosphide into any type of irrigation system (e.g. chemigation).
- Do not allow livestock foraging activity on treated alfalfa until 158 days after application.
- A valid pesticide applicator's license is required for all applications.
