



Dear Customer,

Based on the exemptions to the requirements outlined in 29 CFR §1910.1200(g) *Hazard Communication [HCS 2012]*, *Safety Data Sheets*, listed below, a Safety Data Sheet (SDS) is not required for products comprised of or containing only articles, as defined below:

Hazard Communication [§1910.1200(b)(6)]

(6) [29 CFR §1910.1200(b), *Scope and Application [of HCS 2012]*,] does not apply to:

(v) *Articles* (as that term is defined in paragraph (c) of the section [cited below]);

(c) Definitions

**Article** means a manufactured item other than a fluid or particle:

- (i) Which is formed to a specific shape or design during manufacture;
- (ii) Which has end use function(s) dependent in whole or in part upon its shape or design during end use; and
- (iii) Which under normal conditions of use does not release more than very small quantities, i.e., minute or trace amounts, of a hazardous chemical (as determined under paragraph (d) of this section [cited below]), and does not pose a physical hazard or health risk to employees.

(d) Hazard classifications

(5) *The chemical manufacturer, importer, or employer* shall determine the hazards of mixtures of chemicals as follows:

(iv) If the chemical manufacturer, importer, or employer has evidence to indicate that a component present in the mixture at a concentration of less than one percent (or in the case of carcinogens, less than 0.1 percent) could be released in a concentration which would exceed an established OSHA Permissible Exposure Limit [PEL] or ACGIH Threshold Limit Value [TLV], or could present a health risk to [persons exposed to] those concentrations, the mixture shall be assumed to present the same hazard. [1910.1200(d)(5)(iv)]
