SECTION 4: First aid measures

4.1. Description of first aid measures

Inhalation	Move the exposed person to fresh air. If breathing is difficult give oxygen. If breathing stops, provide artificial respiration. Call a poison control center or doctor for further treatment advice.

Sub-lethal symptoms, if present, would be the result of cerebral edema and should be treated accordingly through administration of an osmotic diuretic and corticosteroid.
